Payment:

The following payment options are available:

- Course Cost £3,999.00, and must be made in £ sterling.
- Credit cards will incur a 3% charge. MasterCard and Visa are accepted.
- Payment will also be accepted via 4 equal instalments of £999.75. If paying by instalments, then payment is in advance of releasing the modules. Instalment 1: Mods 1-3; Instalment 2: Mods 4-6; Instalment 3: Mods 7-9; Instalment 4: 10-12 (12 being practical assessment day) inclusive.

All payments and course fees are non-refundable.

Cancellation Policy:

All payments are non-refundable.
